1. I and my family fully understand using the grounds and trails can be dangerous and using the grounds and trails involves risk and danger of serious bodily injury including permanent disability, paralysis and death. These risks and dangers may be caused by our own actions or inactions, the action or inactions of others, the condition of the grounds and trails and the negligence of Seven Mountains Conservation Corp., Inc. We further understand that the social and economic losses and/or damages that could result from the risks and dangers could be severe and could permanently change my and/or my family's future.
2. I and my family hereby accept and assume all such risks and dangers, known and unknown, and assume all responsibility for the losses, costs and/or damages following any injury, disability, paralysis or death, even if caused in whole or part by the negligence of Seven Mountains Conservation Corp., Inc. by our use of the grounds and trails managed by Seven Mountains Conservation Corp., Inc.
3. I and my family, our heirs, assigns and personal representatives hereby covenant not to sue Seven Mountains Conservation Corp., Inc., and/or the shareholders, directors, officers, agents and employees of it regarding the grounds or trails and my family's use of them for any and all claims, demands, losses, or damages on account of any injury, including but not limited to death or damage to property, caused or alleged to be caused in whole or in part by the negligence of Seven Mountains Conservation Corp., Inc.

I and my family hereby agree to indemnify and hold harmless Seven Mountains Conservation Corp., Inc. and/or shareholders, directors, officers, agents and employees of it and their insurance carrier from any loss, liability, damage or cost they may incur arising out of or related to my and my family's use of the grounds and trails whether caused by the negligence of Seven Mountains Conservation Corp., Inc.
